

Eligibility


Community Bank Buninyong

- Not-for-profit communitybased organisations, including schools, sporting clubs and arts groups, who are incorporated with an ABN or have an Auspicing Agent.
- Auspicing Agent an organisation that meets the eligibility criteria willing to receive project funds on behalf of another group. A letter of support from your auspicing agent should be attached in the Supporting Documents.

Projects that cannot be funded

Community Bank Buninyong

- Individual applicants, businesses, profit-making organisations and political parties
- An activity where the funding is the direct responsibility of the state or federal government
- Projects that have already commenced or have been completed
- Projects based outside the greater Ballarat region





Demonstrating project need

- What sort of data could you use?
- Case studies/stories
- Participation data
- Enrolment data
- Census data
- Health and wellbeing data
- Letters of support individuals, other organisations









Demonstrating community benefit

- How will the community benefit from this project?
- How many people will be engaged in this project?
- Generally, projects are more favourably viewed when more people benefit
- A larger request will require you to show a greater community benefit
- Can you broaden the benefit by tweaking your project idea?
- Can you collaborate with others to maximse the impact and reach?

Will the project leave a legacy?

- Will the project make a lasting impact or leave something helpful for people to remember or use in the future?
- Can you keep it going after the funding ends?







Preparing your budget

- You need to be clear about what you need the money for and how it will be spent
- Are you required to make a contribution?
- Is it a cash contribution or can it be in-kind, e.g. volunteer hours?
- Do you require Committee or Board agreement for a contribution?
- Can you use local suppliers?
- Does it add up?

Organisations with an annual turnover of \$75,000 or more (or \$150,000 for non-profit organisations) are required to register for GST with the Australian Taxation Office (ATO).

Once registered, they must charge GST on taxable goods and services they provide.
